LICENSE ELEMENTS

There are currently six main types of Meme Commons licenses.

MC: Meme Commons

This license gives Licensees permission to copy, distribute, modify, remix, adapt, and use the material in any medium or format, provided the creator is credited. Commercial use is permitted, provided that the Fair Cut is paid under the terms and conditions specified by the Licensor. If you modify, remix, adapt or develop the material, you must license the modified material under identical terms and conditions.

The MC includes the following license elements:

- Credit must be given to the creator
- Adaptations must be shared under the same conditions.
- A Fair Cut is paid to the Licensor under the terms he/she has freely determined

E: Fair Exclusivities

Fair exclusivities cases restrict the freedoms to copy, distribute and/or modify the licensed Work.

This license gives Licensees permission to copy, distribute, modify, remix, adapt, and use the material in any medium or format, except for any specified Fair exclusivity, and provided the creator is credited. Except for the specified Fair exclusivities, commercial use is permitted provided that the Fair Cut is paid under the terms and conditions specified by the Licensor. If you modify, remix, adapt or develop the material, you must license the modified material under identical terms and conditions.

The MC - E includes the following license elements:

MC - Credit must be given to the creator, adaptations must be shared under the same conditions, a Fair Cut is paid to the Licensor under the terms he/she has freely determined.

E - Fair exclusivities cases restrict the freedoms to copy, distribute and/or modify the licensed Work.

V and V2: variable terms

Different terms of Fair cut and/or Fair Exclusivity may be applied to Subsequent Works.

This license gives Licensees permission to copy, distribute, modify, remix, adapt, and use the material in any medium or format, provided the creator is credited. Commercial use is permitted, provided that the Fair Cut is paid under the terms and conditions specified by the Licensor. Unless otherwise specified, commercial use is permitted provided that the Fair Cut is paid under the terms and conditions specified by the Licensor. If you modify, remix, adapt or develop the material, you may license the modified material under variable terms and conditions.

To simplify the identification of the license type, the position of the V determines which license elements and terms are variable.

- The license elements represented by the acronym directly preceding the acronym "V" have variable terms.

- All the license elements represented by the two acronyms that precede the acronym "V2" have variable terms.

MC - V: Variable Fair Cut

If you modify, remix, adapt or develop the material, you may license the modified Work with variable terms of Fair cut.

MC - V - E: Variable Fair Cut; Fair exclusivities as stated

If you modify, remix, adapt or develop the material, you may license the modified Work with variable terms of Fair Cut.

Fair exclusivities cases restrict the freedoms to copy, distribute and/or modify the licensed Work and must be applied to the Subsequent Works under the same terms.

MC - E -V: Fair Cut as stated; variable Fair Exclusivities

If you modify, remix, adapt or develop the material, you must license the modified Work under the same terms of Fair Cut specified by the Licensor.

Fair exclusivities cases restrict the freedoms to copy, distribute and/or modify the licensed Work and may be applied to Subsequent Works under variable terms.

MC - E - V2: variable Fair Cut AND variable Fair exclusivities

Different terms of Fair cut and/or Fair exclusivities may be applied to Subsequent Works.
